- The name of the Trust shall be 'Sri Mata'

3. The office of the said Trust shall be at Moha Badi Ranchi.

4. The objects of the Trust shall be -

(a) To impart education to all students and youth of both the sex irrespective of caste, creed faith and religion and for the public utility in general.

(b) To make provision to the meritorious and poor students for preliminary higher education.

(c) To establish school, collage, institution of any branch namely Arts, science, Commerce Medical, Engineering and all other vocation.

(d) To provide funds to the needy poor and efficient students for acquiring education.

(e) To open and/or establish hospital for students.

5. To achieve the purpose referred to above the trust shall have the right to acquire - property both movable and immovable and also on the terms and conditions as the Trustees may decide, to receive donations and gift from any person, institution or organization.

6. To dispose of by way of sale or by any other alienation any property the proceeds of which to be used for the purpose of the trust & donate funds to Education Institutions.

 8. To take over management of any educational institutions from any person, organisation, trust or body. — — — — —
 9. The trustee shall have the power to appoint any staff teacher, principal and employee, to take disciplinary action against the staff principal teacher or employee and if necessary to discharge any of them. (cont): 4 — — — — —
 10. To open account in the name of the trust with any bank or banks to operate such accounts and to give necessary instructions to the bank.
 11. To give notice to any person and also to initiate legal proceeding whether civil, criminal or revenue in any court against any person and for that purpose to sign pleadings, written statements, pleading petitions, applications and also if necessary to verify on oath any such pleading, petitions and applications.
 12. To appoint a lawyer and to execute a power in his favour.
 13. To appear in court and give statement.
 14. To compromise or compound in proceeding and also to refer the disputes to arbitration

17. The trustee may be removed in a meeting of the Board of the Trust by a majority decision for the purpose of constitution of ~~quorum~~ ^{quorum} of a meeting of the Board of Trust the attendance of at least 3 of the Trustee shall be necessary.

18. The meeting of the Board of the Trust shall be held at least once in a month. The meeting shall be presided over by the settler and in absence of the settler it shall be presided

20 All the internal administration of the Trust and its units will be governed by constitution and by laws to be framed by the Board of Trustees and may be amended time to time by the Trustees for smooth working of the Trust.
